Sub: Suggested Guidelines to be followed by Non COVID hospitals in the event of a patient testing positive for COVID 19

In continuation to our earlier communication in this regard [reference to our mail dated **14.04.2020** and attached letter], kindly find details of the guidelines.

In combatting the COVID -19 pandemic the private health sector is partnering with the government health sector. However, actions taken by few civic bodies in some cities is disheartening.

In the event of a patient testing positive to COVID - 19, in a non COVID hospital rather than shutting down the institution, the following can be carried out.

- 1. Every hospital has a fever clinic with strict protocols on PPE and every suspected case is isolated and tested and the patient flow is such that there is no mixing with other patients.
- 2. The patient who has been tested positive is to be isolated and transferred to a COVID-19 dedicated hospital.
- 3. Disinfect the areas where the suspect patients could have moved such as canteen, pharmacy and parking lot etc.
 - Similarly all areas where patient contacts have moved in the hospital to be disinfected according to guidelines.
 - Following disinfection guidelines, all regular services should be restored [shutting down is not required] to the public in order to overcome inconvenience.
- 4. In the event of COVID suspect or confirmed having being admitted in the ICU or isolation rooms' disinfection to be done as per MOHFW guidelines.

- 5. Testing by RT-PCR or rapid antibody testing of all symptomatic cases, history of travel, history of contacts as per the definition provided by MOHFW.
- 6. Hospital management should closely monitor the infection prevention steps being taken and communicate timely with District/ State administration.
- 7. Daily meeting of top management, ID Physicians, Infection Prevention team will help to understand the patient flow, dynamic situation with reference to guidelines and resource allocation.
- 8. Staff in the front line management to be offered HCQS prophylaxis as per ICMR recommendations.

These guidelines will prevent inconvenience to the other patients.
